REPORT FROM THE BOARD

The Board is pleased to present its report and the foundation's financial statements for the year 2024. Pursuant to its Articles of Association, the objective of the Foundation is:

to support the education of persons who are not capable of doing so independently. Preference in this respect is given to the support of persons who have exhibited an above-average talent or aptitude and, currently, to young people who live in Asia or Africa and have been admitted to a secondary, vocational or university educational institution in Asia or Africa.

In 2024 the foundation continued to support Herbert Ochen by paying the cost of his studies at the medical faculty of the Kampala International University in Uganda and the cost of his living expenses, € 8,940 in total. The foundation also contributed to the cost of the studies of Edward Ombui Mogusu and Joshua Bahati Katana at the Technical University of Mombasa, Kenya. They each received € 1,000 in 2024.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR 2024

General

The foundation has been incorporated at 27 May 2005 and has been governed by its Articles of Association. The foundation has obtained the ANBI-status and is thereby officially recognised as a charity institution.

Accounting policies

Unless indicated otherwise, assets and liabilities are shown at face value. Results are recorded in the period in which they originate, based on estimates if applicable. Income and expenses are allocated to the period in which they arise. As a consequence, the realization may include provisions for expenses, based on estimates if applicable.

Investment Policy

The investments are managed by Wealth Management Partners. Given the long term goals and the endowment character of the foundation the assets will be held in Equity (between 30 and 60%) and in Government and/or Corporate Bonds (between 40 and 70%), mainly Investment Grade and in Euros denominated.
