REPORT FROM THE BOARD

The Board is pleased to present its report and the foundation's financial statements for the year 2024.

Pursuant to its Articles of Association, the objective of the Foundation is to support nature conservation projects in Europe and Africa, giving priority to the following projects over others:

- Projects that seek to precipitate long-term conservation benefits.
- Projects that give reason to assume that they can become self-supporting or be able to levy further funds over time.
- Projects that are initiated and/or executed by volunteers.
- Projects that pay considerable attention to their educational impact.

In 2024 the Mr. H.G. Boumeester foundation granted € 7,490,- to the Greenmanjaro Foundation; € 5.000 for its treeplanting project in the Lower Moshi area and € 2.490 for its Climate Care Education project and for the purchase of 25 fruit trees and 20 shadow trees for 3 schools, also in the Lower Moshi area. With these donations, we want to contribute to the positive environmental impact of these projects and to a positive change in the ecological stewardship and green society of Kilimanjaro and the surrounding areas.

The surplus for the year 2024, \in 53.349, has been added to the free reserves of the foundation.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR 2024

General

The foundation has been incorporated at 27 May 2005 and has been governed by its Articles of Association. The foundation has obtained the ANBI-status and is thereby officially recognised as a charity institution.

Accounting policies

Unless indicated otherwise, assets and liabilities are shown at face value. Results are recorded in the period in which they originate, based on estimates if applicable. Income and expenses are allocated to the period in which they arise. As a consequence, the realization may include provisions for expenses, based on estimates if applicable.

Investment Policy

The investments are managed by Wealth Management Partners. Given the long term goals and the endowment character of the foundation the assets will be held in Equity (between 30 and 60%) and in Government and/or Corporate Bonds (between 40 and 70%), mainly Investment Grade and in Euros denominated.
